On Saturday, March 16, 2024 and Sunday, March 17, 2024, AUTUMN WINDS AGILITY CLUB (AWAC) will host two agility trials per day, under the regulations of the United Kennel Club, Inc. This off-lead trial is open to all UKC registered dogs that are **fifteen months of age or older. Beginner Agility (BA), Intermediate Agility (IA) & Excellent Agility (EA) titling classes will be offered.**

Entry in the IA class is open to dogs with or without the BA title. A dog may be entered in the BA and IA classes at the same trial. Entry in the EA Class is open only to those dogs that have completed the requirements for the Agility Champion title (UACH). Only dogs with a UACHX title are eligible to compete for the UGRACH title.

Trial I will begin promptly at 8:30 am with a Judge's briefing & course familiarization for handlers. Course familiarization with dogs will be on lead at the beginning of each height division for BA-A and IA-A.

Trial 1 will begin at 8:30 am; Trial 2 will immediately follow Trial 1 for each class category. Trials will be run BA, EA and IA. Trial 1, BA will be followed by Trial 2, BA, and continue with each class. This will be the running order on both days.

To Register - Entry Forms

Please use a **current**, official UKC entry form. Use one entry form per dog.

Be sure to indicate if your dog is in section A or B (BA-B, IA-A, etc.). "A" is for dogs who have not yet attained a title in that class; "B" is for dogs working towards their UACH or higher. Handlers, trainers, and judges must show in section B, but if their dog has not attained a title, they may also participate in the course familiarization with their dog. There are no A or B divisions in EA.

If you will be running your dog at the minimum jump height, please make sure you mark this on your entry form as well.

Pre-entry:

To register, fill out a current UKC entry form. Pre-register entries close at 6:00 PM on March 9, 2024, or when the event limit (200 runs per day) is reached.

Entry fees are \$18 for the first entry and \$16 for the second entry of the **SAME dog in the SAME trial**. Entry fee for **SAME dog running in all 3 classes in the SAME trial** is \$45.

For example if:

Spot is entered in BA & IA, Trial 1 – Cost $\$18 + \$16 = \$34$.

Spot entered in BA, IA & EA Trial 1 – Cost \$45

**But if Spot is entered in BA, Trial 1 and Trial 2 – Cost $\$18 + \$18 = \$36$
(one dog in two different trials)**

Day of Show Entry:

Day of Show (DOS) Entry will be held from 7:30-8:00 AM. Entry fees are \$22 for the first entry and \$18 for the second (or third) entry of the **SAME dog in the SAME trial**.

FOR DOS ENTRY: Forms will be available on site, however, it would help facilitate the process by bringing your completed entry form with you.

Awards: Rosettes and prizes will be awarded for High in Trial, High Combined and High Triple. Placement ribbons and prizes will be awarded to the first through fourth place qualifying dogs in each class in each trial. All qualifying scores will receive qualifying ribbons.

Equipment will be provided courtesy of the Autumn Winds Agility Center. The trials will be held outdoors on a grass surface, rain or shine. All dogs must be on lead or crated except when exhibiting in the ring. Bring chairs, water, and shade.
NO food vendor will be on site.

Notice to Exhibitors:

- The safety of the dogs is of primary importance. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all of the obstacles safely.
- Choke collars, pinch collars, electric and dummy electric collars are prohibited.
- Food and toys are not permitted in the course area. Handlers are not permitted to use whistles or other instruments or devices.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial judge, be asked to leave the show site. In such case, no refund of any fees will be made.
- Please be considerate of others and clean up after your dog at the trial site.
- Entry fees shall not be refunded in the event that the dog is absent, disqualified or excused by Veterinarian or Judge. Refunds will be provided for persons withdrawing before October 28, 2023. AWAC will retain a \$5.00 handling fee for processing the early withdrawal. If it is impossible to operate or complete the show, due to acts beyond control of the management, no refund of entry fee will be made.
- Judge will not wait for any dog holding up the judging of a class.
- Incorrect/incomplete entries, late entries or entries received without the appropriate fees will not be accepted. Minor questions may be handled by e-mail or telephone.
- Bitches in season will not be allowed on the premises during the trial.

NO RV PARKING/CAMPING will be
allowed on the grounds.
